SALES AGREEMENT

The buyer asks the seller to order a stallion card of « Chacco White » on following conditions :

- **200€** VAT excluded → Technical fee for reservation (must be paid at the contract signature – not refundable)
- Stud fee : 2 possibilities (tick your choice) :
 - 750€** VAT excluded if paid for the date = max. 1st October 2025. (If mare is in foal.)
 - 900€** VAT excluded if paid at the birth of the foal. (If alive after 48h.)

The buyer must inform the seller of the foreseen birthdate of the foal. The buyer pays the stud fee before 1st October 2025 OR max. 8 days after the birthdate (depending on the ticked possibility). If payment not received for the correct date, interests will be charged.

TERMS OF USE (Conditions)

1. The semen is reserved for mare :Sire nr (if available):.....

The buyer wants to make « embryo transfer » : YES - NO (Circle the right choice.)
2. Stud fee does not include VAT, transport costs and health certificates. Doses/straws not used remain the property of the seller.
3. Applicable VAT: 6% for semen and 21% for delivery fee.
4. Veterinary fee and pension fee are for the buyer.
5. **Only one mare by contract.** The breeder undertakes to send a copy of the mare passport in order to be able to draw up the stallion certificate. If the mare is sold before the birth of the foal, the terms of the contract remain for the new owner.
6. The reservation of the semen is effective upon receiving the signed contract and the receipt of payment of technical fee. The signatory of this contract is legally liable for payment of the semen. In the event of the resale of straws, the terms of this agreement shall continue to apply to the straws' new owner.
7. ICSI procedure or other technic not applicable through this agreement. For information about ICSI, email bdhorsesprl@gmail.com

Fraudulent use

Any fraudulent use of semen will be prosecuted. In case of fraud or proven attempted fraud in relation to these agreement terms (Doses/straws used and not used; registration of the foal in a studbook without payment of the semen, fraudulent using of semen; payment not done; ...) the buyer will be liable to pay the seller a lump sum of eur 5.000€. Any dispute directly or indirectly relating to our contractual relations with the buyer is the exclusive jurisdiction of the Courts and Tribunals of Namur.

Sending doses is not automatic ! It is done at the express request of the buyer.
